Dear Sir or Madam:

Enclosed is a settlement notice approved by the Court for the remaining Airfreight Shipping Services Settlements, or the Air Cargo Settlement 5. You will see that the notice refers to settlements with Defendants Asiana Airlines, Inc. ("Asiana"), EVA Airways Corporation ("EVA") and Nippon Cargo Airlines Co., Ltd. ("Nippon Cargo"), and also with Defendants Air China Limited and Air China Cargo Company Limited ("Air China"), Air New Zealand Limited ("Air New Zealand"), Air India Limited ("Air India"), and Polar Air Cargo LLC, Polar Air Cargo Worldwide, Inc., and Atlas Air Worldwide Holdings, Inc. ("the Polar Defendants").

As described in the notice, because you submitted an approved claim form in connection with one or more of the previous Settlements (Air Cargo 2, Air Cargo 3, or Air Cargo 4), you do not need to submit an entirely new claim form to get a payment in Air Cargo Settlement 5.

However, because the Class Period for the Air China, Air India, Air New Zealand, and Polar Defendants Settlements is 19 days longer than for previous settlements, we have attached a Supplemental Claim Form which covers the additional time period -- from September 12, 2006 to September 30, 2006. If you purchased airfreight shipping services directly from the Defendants or Settling Defendants for shipments to or from the United States from September 12, 2006, to September 30, 2006, please complete, sign and return the attached Supplemental Claim Form so that it is postmarked no later than September 9, 2016.
